Pool Rules and Regulations

The Whittington Hall Homeowners Association Board of Directors has adopted these rules and regulations for the community pool. Failure to abide by the following rules and regulations may result in the loss of privileges to these facilities.

Pool Operations:

1. Swim season is from May until September
2. General Pool hours are Monday through Sunday from dawn to dusk.
3. Any homeowner delinquent in HOA dues shall have pool privileges revoked until all said dues are paid in full.

Pool Regulations:

1. A parent, legal guardian, or other designated resident of Whittington Hall with a minimum age of 16 years must accompany persons under the age of 14.
2. Each household is permitted **four** (4) guests per visit. Anyone having more than 4 guests must have this approved by the Board of Directors. Children under the age of 14 are prohibited from bringing guests without adult supervision.
3. Residents may have small gatherings /celebrations, subject to all pool rules and regulations, at the pool. Parties will be permitted primarily Monday - Thursday and must be approved by the Board of Directors. **No parties will be approved on Federal holidays. Please note: When a holiday falls on a Monday or Friday parties will not be approved for the holiday and the holiday weekend. A \$50 fee and a \$200 deposit along with a reservation form will be required prior to the party.** Adult Supervision is required as follows:
 - **Ages 5 and under - maximum of 10 children. One adult per child required**
 - **Ages 6-12 - maximum of 15. One adult per two children.**
 - **Ages 13 and over - maximum of 20. One adult per 4 kids under 21.**
 - **No children under 21 will be allowed at the pool during an adult social unless accompanied by an adult.**

Neighborhood functions may be held on the weekends and holidays with Board approval.

Pool Rules:

1. No one may swim at anytime without another person in the pool area.
2. Absolutely **NO BALLOONS**. Balloons can damage the pump.
3. **NO PROPPING THE GATE OPEN.**
4. No diving.
5. **No running, horseplay, boisterous conduct, or inappropriate language shall be permitted. This includes rough play with balls of any type, frisbees, or any other object.**
6. **No glass containers are permitted within the pool area.**
7. No extension cords or electrical equipment of any kind shall be used around the pool area other than battery powered radios or telephones.
8. Radios or other sound producing devices must be kept on a low volume as to not disturb others within the immediate area.
9. Food and beverages shall be restricted to seating areas.
10. No food, drink, or gum is allowed in the water.
11. Swimmers must wear appropriate swimming attire while in the pool. No cut-off blue jean shorts allowed.
12. No animals are allowed in the pool area at any time.
13. No open flame or charcoal grills are allowed within the pool area or clubhouse grounds unless organized by the social committee for a community function.
14. No disposable diapers, other than disposable swim diapers are permitted in the pool, in accordance with the Health Department regulations. Children not toilet trained must wear cloth diapers and rubber pants that are fitted around the waist and legs. Non-compliance could cause the pool to be closed by the Health Department.
15. No bicycles, skateboards, scooters, rollerblades or similar items are permitted in the pool area.
16. Persons who violate the above rules will receive **ONE** warning. The warning will be communicated in writing or by phone and on record at the management company. There will be a 30 day suspension of pool privileges if the infraction is repeated.
17. **NO SMOKING**
