AMENDMENT
TO DECLARATION OF CONDOMINIUM
FOR CANAAN AT THE NOLES
CONDOMINIUM

GUILFORD COUNTY

THIS AMENDMENT TO DECLARATION OF CONDOMINIUM FOR CANAAN AT THE NOLES CONDOMINIUM, Made and entered into, effective as of the 9th day of August, 2011, by CANAAN AT THE NOLES CONDOMINIUM ASSOCIATION, INC., a North Carolina non-profit corporation, hereinafter referred to as "Association."

WITNESSETH:

WHEREAS, the Declaration of Condominium for Canaan at the Noles Condominium (the "Declaration") is recorded in **Book 6610, at Page 2587**, of the Guilford County Registry, and as previously amended;

WHEREAS, at a special meeting of the Association held on August 9th, 2011, the owners of the Association, after proper notice, considered a proposed amendment to Article 19 of the Declaration;

WHEREAS, ninety percent (90%) or more of the owners of the Association voted to approve the amendment to Article 19 of the Declaration as set forth below; and

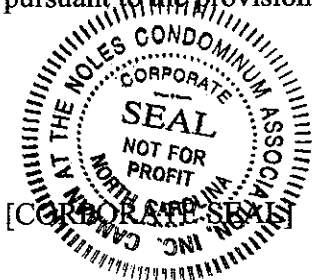
WHEREAS Article 29 of the Declaration provides for the manner of amendment of the said Declaration, and the amendment set forth herein has been and is being duly made in accordance with the procedures set forth for amendment in the Declaration.

NOW, THEREFORE, the undersigned, President and Secretary of Canaan at the Noles Condominium Association, Inc., do hereby set forth the duly approved amendment to the Declaration:

Insert the following new provision under Article 19, entitled "MAINTENANCE AND REPAIR OF UNITS BY UNIT OWNER(S)":

"19.3 Unit Owners shall have the right to install landscaping plants and drip irrigation in the side or rear yards adjacent to their Unit. The Unit Owner's installation of such landscaping plants and drip irrigation systems, including any replacements or additions thereto, shall be subject to the prior written approval of the Executive Board of the Association, or its duly appointed committee. Each Unit Owner shall be responsible for all necessary maintenance, removal, and replacement of all landscaping plants and drip irrigation systems which are located in the side or rear yards immediately adjacent to the Unit Owner's Unit. All landscaping and drip irrigation installed by the Declarant in the front yard of each Unit shall be maintained by the Association as part of the Common Elements pursuant to the provisions of Article 20 below."

IN WITNESS WHEREOF, the undersigned duly authorized officers of the Association hereby attest that the requisite owner approval has been obtained as evidenced by written acknowledgments signed by the owners and made a part of the minutes of the Association pursuant to the provisions of Article 29 of the Declaration.


