# SECOND AMENDMENT TO THE DECLARATION

## OF COVENANTS, CONDITIONS AND RESTRICTIONS

#### ARTICLE I

#### ARTICLE II

#### ARTICLE IV

The Declarant and Owners recorded an Amendment to the Declaration of Covenants, Conditions and Restrictions in Book 1598, page 1192, in the Office of the Register of Deeds of Davidson County, North Carolina.

#### ARTICLE V

The parties hereto desire to amend the Declaration of Pennfield by deleting Article VI, Section 1, Maintenance of Common Area and Lots and adding the following language:

SECTION 1. MAINTENANCE OF COMMON AREA AND LOTS. The Association shall maintain the Common Area. The Association shall be responsible for the exterior maintenance of each dwelling and Lots, as follows: painting, replacement and care of roofs, gutters, downspouts, exterior building surfaces, lawn, trees, shrubs, driveways, walks and other exterior improvements. The determination as to whether an Owner has neglected or failed to maintain his lot and dwelling in a manner consistent with other Lots and dwellings in PENNFIELD shall be made by the Board of Directors of the Association. The Association shall be responsible for the exterior maintenance except for the following: glass, screens, doors and hardware, lighting bulbs, plumbing, electrical, HVAC equipment, water and sewer lines and additions.

The above are all the owners of the lots in Pennfield.
