NOW, THEREFORE, Declarant hereby amends the Declaration and declares that all the properties to be known as Section 3A of The Gates more particularly described as being all of the property so designated and recorded in Plat Book 184, Page 44 of the Guilford County Registry, shall be held, sold and conveyed subject to the easements, restrictions, covenants and conditions as recorded in the Declaration, which are for the purpose of protecting the value and desirability of, and which shall run with the real property and be binding on all parties having any right, title or interest in said property, or any part thereof, their heirs, successors and assigns, and shall inure to the benefit of each owner thereof. By accepting the deed to any portion of such property, the owners thereto agree to abide by all of said covenants, conditions and restrictions including their agreement to pay any assessments levied pursuant thereto.

This Amendment shall be treated as an expansion of the tract subjected to the abovereferenced Declaration and the Declarant will convey the "Common Elements," if any, (as that term is defined in the Declaration) within said Subject Property to the Association prior.
