## AMENDMENT OF DECLARATION OF COVENANTS, CONDITIONS AND RESTRICTIONS **FOR**

THIS AMENDMENT OF DECLARATION OF COVENANTS, CONDITIONS AND RESTRICTIONS FOR COTTESMORE (SINGLE FAMILY) ("Amendment") is made as of March 10, 2006, by WILLARD DAIRY ROAD ASSOCIATES, LLC, a North Carolina limited liability company ("Willard"), K. Until December 31 of the year of the conveyance of the first Lot to an Owner, the maximum annual assessment shall be One Hundred Twenty and No/100 Dollars (\$120.00) per Lot, and may be collected in monthly installments of Ten and No/100 Dollars (\$10.00).

Miscellaneous. The recitals set forth above are true and correct and are made a 2. part of this Amendment. Capitalized terms not otherwise defined herein shall have the meanings ascribed to them in the Declaration. Except as set forth herein, the Declaration remains unmodified and in full force and effect.
