THIS AMENDMENT TO THE DECLARATION OF COUNTRY CLUB WEST HOMEOWNERS ASSOCIATION is made this 15 day of 1020 hereinafter set forth by COUNTRY CLUB WEST HOMEOWNERS ASSOCIATION f/k/a TREYMONT POINTE HOMEOWNERS ASSOCIATION, a North Carolina non-profit corporation (the "Association").

Background

K & C Development Corporation has caused a Declaration of Covenants, Conditions and Restrictions for the Association to be recorded in Book 636 Page 587 in the office of the Register of Deeds for Davidson County, North Carolina and which has been amended by (i) Amendment to the Declarations of Treymont Pointe Subdivision Changing the Name of the Subdivision to Country Club West, Phase I and Annexation of Country Club West, Phase II recorded in Book 770 Page 1027 in the office of the Register of Deeds for Davidson County, North Carolina and (ii) Amendment to the Declarations of Country Club West recorded in Book 797 Page 1343 in the office of the Register of Deeds for Davidson County, North Carolina (the "Declaration"). The Association desires to amend the Declarations in regards to delegation of use and rental.

Amendments

The Association hereby amends the Declaration as follows:

Article II, Section 2, <u>Delegation of Use</u> is amended and restated as follows:

Submitted electronically by "Wyatt Early Harris Wheeler LLP" in compliance with North Carolina statutes governing recordable documents and the terms of the submitter agreement with the Davidson County Register of Deeds.

<u>Section 2.</u> <u>Delegation of Use.</u> Any Owner may delegate, in accordance with the By-Laws, his rights of enjoyment of the Common Area and facilities to the members of his family or his tenants (which shall not exceed a total of six weeks in a calendar year) who reside on the property.

Article VIII is amended to add the following:

<u>Section 9.</u> <u>Rental.</u> Notwithstanding anything herein to the contrary, no Owner shall rent its Lot, or any structure located upon its Lot, for a period in excess of six weeks in a calendar year, whether the rental period is consecutive or in the aggregate.

Except as specifically modified and amended herein with respect only to delegation of use and rental, the Declarations shall remain in full force and effect.
